ORDER:-

In the reference 1<sup>st</sup> read above, the Managing Director, A.P.Township and Infrastructure Development Corporation Limited has reported that the Government of India, Ministry of Housing and Urban Poverty Alleviation (HFA-III) has sanctioned Rs.55,18,88,000/- (Rupees fifty five crores eighteen Lakhs eighty eight thousands only) towards 1<sup>st</sup> instalment as Central Grant (Scheduled Caste Component) for Creation of Capital Assets under PMAY (Urban) for the Financial Year 2017-18. Therefore, the MD, APTIDCO has requested the Government to release the Administrative Sanction and Budget Distribution Letter for release of Rs.55,18,88,000/- (Rupees fifty five crores eighteen Lakhs eighty eight thousands only) to the PD Account of Managing Director, APTIDCO vide bearing No.34/CRT.

2. The Finance Department vide reference 2<sup>nd</sup> read above have issued Budget Release Order for an amount of Rs.55,18,88,000/- (Rupees fifty five crores eighteen Lakhs eighty eight thousands only) as additional funds in relaxation of Treasury Control and Quarterly Regulation, pending provision in supplementary estimates at appropriate time during the financial year towards meeting the expenditure under Pradhan Mantri Awas Yojana (PMAY) (Urban).

3. Accordingly, Government hereby accord administrative sanction for utilization of the amount of Rs.55,18,88,000/- (Rupees fifty five crores eighteen Lakhs eighty eight thousands only) as additional funds in relaxation of Treasury Control and Quarterly Regulation, pending provision in supplementary estimates at appropriate time during the financial year towards meeting the expenditure under Pradhan Mantri Awas Yojana (PMAY) (Urban) under the Head of Account 2216-80-789-12-SH (06)-310-319.

4. The Assistant Secretary to Government (Drawing and Disbursing Officer) Municipal Administration and Urban Development Department, Andhra Pradesh shall draw the amount of Rs.55,18,88,000/- (Rupees fifty five crores eighteen Lakhs eighty eight thousands only) and adjust the said amount to the P.D. A/c No. 34/CRT of APTIDCO.

5. The Director of Treasuries and Accounts, A.P., Vijayawada / Director of works Accounts, AP shall accord necessary budget authorization to the bills

submitted by the Assistant Secretary to Government & Drawing and Disbursing Officer, MA&UD Department, A.P., Secretariat as indicated in the Budget Release Order issued vide reference 2<sup>nd</sup> read above.

6. The Managing Director, APTIDCO, Vijayawada shall take necessary further action in the matter.

7. This order issues in accordance with the Budget Release Order issued by the Finance Department vide their U.O.No. 44027/34/2018-FMU-I,E,M, Dated:16.02.2018.

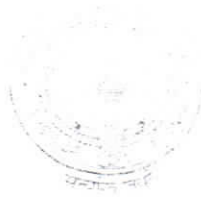
