- 7. The deigns, drawings and estimates shall be prepared duly following the guidelines of CPHEEO Manual, IS Codes as amended from time to time with current SoR and as directed by departmental authority.
- 8. The Consultant shall carry out all the necessary investigations as per site condition including the Preliminary Investigation Survey, topographical survey, contours, etc in the approved layout PMAY-HFA Colonies in consultation with the engineers of APTIDCO,PHMED, Municipalities and other line department.
- 9. The Consultant shall submit investigation reports, designs and drawings; necessary plans detailed estimates and all the other required documents for carrying out tendering process. They shall extend their services throughout the execution of JMM centres, where and when any alterations, omissions, additions occurred.

- 10. It is the responsibility of the Consultant to get all the documents scrutinized and obtain approval from the competitive authority.
- 11. The Final copies of all the documents DPR's shall be given to APTIDCO in Triplicate.
