**ORDER:**

Government vide reference 2<sup>nd</sup> read above, for effective implementation of the mission “Pradha Mantri Awas Yojana- Housing for All (Urban)”, and to optimally utilize the central assistance and enable a sustainable delivery mechanism for affordable housing in the long term, have constituted and incorporated Andhra Pradesh Township and Infrastructure Development Corporation (APTSIDCO) under Municipal Administration and Urban Development Department bringing three (3) of the four (4) vertical components of PMAY-HFA (U) viz (a) In-situ Slum redevelopment (b) Affordable Housing in Partnership (AHP) and ( c) Credit linked subsidy scheme components under the administrative control of MA&UD Department, A.P. Secretariat leaving only Beneficiary Led Individual House Construction (BLD) component with the A.P. State Housing Corporation Limited (APSHCL) and the Housing Department A.P Secretariat and nominated the Andhra Pradesh Township and Infrastructure Development Corporation (APTSIDCO) as

State Level Nodal Agency for Housing For All (HFA) and also appointed 12 Board of Directors to APTSIDCO making the Principal Secretary to Government, MA&UD Department as the Chairman.

2. The Ministry of Corporate Affairs, Government of India vide their ID Note No.17/2/2016 CL-V dated 26.07.2016 accorded permission to use the word 'Corporation' as part of the proposed name " Andhra Pradesh Township and Infrastructure Development Corporation Limited" under Section 4(3) (b) of the Companies Act, 2013 read with Rule 8(6)(n) of Companies ( Incorporation) Rules, 2014 subject to availability of name.

3. Government in pursuant to the permission accorded by the Ministry of Corporate Affairs, Government of India and in the circumstances reported by the Managing Director, Andhra Pradesh Township and Infrastructure Development Corporation Limited have issued orders reconstituting the structure of the Board of Directors of APTSIDCO by expanding the strength of the Board of Directors vide reference 5<sup>th</sup> read above.

4. The Ministry of Housing and Urban Poverty Alleviation, Government of India have suggested that the State Government shall constitute the State Level Sanctioning and Monitoring Committee (SLSMC), State Level Technical Cell (SLTC) and City Level Technical Cell ( CLTC) for effective implementation and success of the Housing For All Scheme.

5. Government after careful consideration hereby constitute State Level Sanctioning and Monitoring Committee (SLSMC), State Level Technical Cell (SLTC) and City Level Technical Cell ( CLTC). The Committee and the Cells shall encompass with the following members:

7. The Managing Director, A.P. Township & Infrastructure Development Corporation Limited, Vijayawada is accorded permission to sight the Memorandum of Agreement (MoA) with the Government of India for release of funds for the three (3) of the four (4) vertical components of PMAY-HFA (U) viz (a) In-situ Slum redevelopment (b) Affordable Housing in Partnership (AHP) and ( c) Credit linked subsidy scheme components which are under the administrative control of MA&UD Department, A.P. Secretariat
