In pursuant to the orders issued in the references 1st to 9th read above, Government hereby appoint Sri Ramnath as Executive Vice Chairman to Andhra Pradesh Township & Infrastructure Development Corporation Limited, Vijayawada initially for a period of 2 years from the date of assuming the charge.

2 The Executive Vice Chairman shall be responsible for development of economic cities on private land by private parties and on government land by private parties. He shall bring the experience and efficiency of private sectors in planning, designing, development models, construction technologies and overseeing the construction and development works for faster and quality development. He shall also support the Managing Director, APTSIDCO in development of plans for EWS and LIG as well as slum redevelopment designs to bring in uniformity to the total objective of the government of 'Housing for All'.

3. The Executive Vice Chairman shall develop a team as per the work requirement duly procuring the man power from open market on contractual basis and from Governmental Departments/Organizations/Institutions on deputation basis after the approval of Board of Directors APTSIDCO.
