ORDER:

The Ministry of HUPA, Govt of India, New Delhi has launched flagship programme of Housing for ALL (HFA) by 2022. The Mission seeks to address the housing requirement of urban poor including slum dwellers through following programme verticals:

- i. Slum rehabilitation of Slum Dwellers with participation of private developers using land as a resource.
- ii. Promotion of Affordable housing for weaker section through credit linked subsidy.
- iii. Affordable housing in Partnership with Public and Private sectors.
- iv. Subsidy for beneficiary-led individual house construction.

2. As per Pradhana Mantri Awas Yozana-Housing for All (Urban) scheme guidelines, the State Government has to notify State Level Nodal Agency for coordinating the scheme and reforms related activities.

3. The Government after careful examination of the matter, hereby notify the Principal Secretary to Government / Secretary to Government, Housing Department as State Level Nodal Agency for the State of A.P. to implement Housing for All in Urban Areas.
